- Graduation in concerned faculty as indicated in above table.
- Master's degree is concerned with subjects with at least 55% marks as indicated in above table.
- For the candidates having master's degree, NET shall remain compulsory along with one publication in NAAS rated referred journal for recruitment to the post of Assistant Professor and equivalent in the disciplines in which NET is conducted. Essentiality of NET can be waived off for the candidates holding Ph.D. degree provided it has been done with course work as prescribed by the UGC Regulations, 2009 (and also as per ICAR letter No. 23(46)/2010-EQR (Edn.) dated 26<sup>th</sup> December, 2011, issued by ADG (EQR), and the candidate has at least two full length publications having a NAAS rating of not less than 4.0 on the last date of submission of applications. Those candidates with Ph.D. degree without course work will not be considered for NET exemption.

1. The Posts /Vacancies are purely temporary/Short term and will be filled on contractual basis for academic Session 2025-26.
2. A sum of Rs. 600/- per post/per candidate for Guest Faculty/Teaching Associate will be charged as processing fee (non-refundable) in cash at the time of Walk-in- interview.
3. The interested eligible candidates are invited to participate in Walk-in Interview for Guest Faculty /Teaching Associate. The eligible candidates should bring all original certificates and along with one set photocopy of the same at the time of walk-in-interview. Testimonials will be verified.
4. The candidate will have to give one- month's advance notice if he/she desires to leave the job failing which he/she will have to surrender one-month salary in lieu of the notice period. However, his/her resignation will only be accepted to join other permanent jobs. The candidate will not be allowed to join higher degree course / higher education during the tenure.
5. The university reserves the right to reject one or all the applications without any reason thereof.
6. The University reserves the right to increase / decrease / cancel the no. of guest faculty (Teaching Associate) or cancel/reschedule the Walk-in-Interview at any time without assessing any reason and will be notified on University Website only, therefore eligible candidates are advised to visit the website regularly.
7. T.A/D. A will not pay Candidate to attend the walk- in-interview.

8. In case of selection, he/she will report for duty within 15 days from the date of issue of the engagement failing with his/her selection will be treated as cancelled and may be offered to any other candidate. The place of work will be at Place of the concerned faculty /department or as directed. The University reserve the right to cancel the interview at any stage without prior Information.
9. In case of any disputes, any suites or legal proceedings against the University, the territorial jurisdiction shall be restricted to District Court at Kanpur City and High Court at Lucknow & Allahabad only.
10. Corrigendum or Addendum or Cancellation to this advertisement, if any, shall be published only on the University Website: [www.csauk.ac.in](http://www.csauk.ac.in) and will not be published in the newspapers. Therefore, candidates are advised to check the University Website regularly.
11. The engagement will be as indicated above. However, if the work and conduct is not found satisfactory, the services can be terminated at any time after giving due opportunity of being heard with one month's notice to the person concerned. It is worth mentioning that if posts are filled through regular selection process, appointment of candidate(s) shall be stand cancel automatically.
12. If the selected candidates(s) want to leave, he/she can do so after giving notice in writing to the University.
13. All the selected guest faculties (Teaching Associate) have to teach the students as directed by the authority from time to time and may be engaged for examination and evaluation of examination answerbook.
14. The incumbent shall be placed for a specified period and no claim for adjustment in the University.
15. The Guest Faculty will not be treated like regular teachers for the purpose of voting rights or for becoming the members of the various statutory bodies of the university.
16. The Guest Faculty will not be given the benefit of allowances, pension, gratuity and leave etc. as admissible to the regular teachers.
17. She/he will not be treated as regular employee of the University and will not be entitled to any GPF or other benefits admissible to the regular employee.
18. Candidates who are attending interviews should bring the certificate of respective categories as per specified format of the Government for reservation claim. In absence of eligible candidate of reserved category for the position at the time of interview, the position might be filled up by the eligible candidate of other categories who attended the same interview.
